

Emerald Fields/Veritas Ski and Snowboard Giveaway: Official Rules

ELIGIBILITY. The Emerald Fields/Veritas December Giveaway (the “Giveaway”) is open only to:

- (1) Individuals who are twenty-one (21) years of age or older, and
